# ADMINISTRATION TEAM REPORT

### Administration Team Report

1. On 5/12/2020 the Administration Team approved the recommended motion submitted by the Administrative Commission for the Presbyterian Church in Nauvoo, IL as stated below. Julio Garcia

The session of the Nauvoo Church is anxious to get moving forward so the hope of the Commission is that the Administration Team vote can be concluded by noon on Thursday, May 14, 2020.

To approve the sale of the physical assets including the building and real estate of the First Presbyterian Church of Nauvoo, IL by auction at the request of the Session and the Congregation. The Session will contract with a licensed auctioneer for a sale to be held in July or early August 2020 pending the availability of auctioneer.

- 2. On April 7, 2020 a special Admin Team Meeting was called to deal with the following issues:
  - Westminster Springfield submitted a PILP loan request for \$1,166,700. This loan would be used for building and lot upgrades.
    - Discussed the assets of the Presbytery and the assets of the church available if the church were to default on the loan.
    - Discussed the possibility of the church choosing to delay the loan because of COVID-19.
    - **MSA** to cosign the PILP loan as a guarantor.
    - Bill Strawbridge will communicate with the representative of the church the decision of the Admin team.
  - It was discussed that Ryan and Bill S. would work together to form an ask for larger churches in the Presbytery to assist smaller churches with grant and loan writing as many larger churches have resources beyond the smaller churches.
  - Discussed the CARES act and Small Business Loans. Julio and Bill S. were on the Synod call yesterday that talked about these in depth.
    - There is no collateral or co-signing needed. Therefore, advice from the OGA and Synod states that Presbyteries do not need to approve the individual loans. The Book of Order states the Presbyteries are responsible for encumbered loans and these do not fall under that category.
    - Bill spoke to the fact that in applying for these loans, the church does not need to demonstrate repayment ability.
    - The purpose of these loans is to keep people employed and it is being treated like a grant.
    - **MSA** for Bill Strawbridge to send out packets to the churches about how they could apply if they chose to do so.
    - Bill and Ryan will work together to come up with a "30,000-foot view" of what the program is for to help pastors and churches.
- 3. On April 8, 2020 the Admin. Team sent out the following Guidance:

Administration Team Guidance on Federal Aid for Churches from the Presbytery of Great Rivers

We are called to share Christ's love by partnering in service, uniting in worship and risking in ministry.

April 8, 2020

Friends,

We pray you and yours are well.

As many of us witnessed during the 2008/2009 economic crisis, providing the best data and forecasts we can in assisting leadership with the discernment of "next steps", both in the short and long terms, is crucial.

We are grateful that there are many options for assistance in response to the current COVID-19 crisis that include but are not limited to those offered by Presbyterian Disaster Assistance, the Board of Pensions, the Presbyterian Investment & Loan Program (PILP), and also the Small Business Administration's (SBA) Paycheck Protection Program loans with limited resources being offered to roughly 30.2 million businesses, many of which have been closed for weeks.

The Paycheck Protection Program (PPP) is designed to keep small businesses, including qualifying non-profit organizations, afloat during mandated Coronavirus Disease 2019 ("COVID-19") related closures.

This new loan program will make potentially forgivable loans available to qualifying small businesses. Most non-profit organizations, that generally have less than 500 employees, are eligible to apply. In evaluating eligibility for such loans, lenders are to consider: (1) whether the borrower was operational on February 15, 2020, and (2) whether the borrower was paying salaries and payroll taxes for employees and independent contractors at that time.

PPP loans can be forgiven to the extent that the loan proceeds have been used for the following costs incurred and payments made during the eight-week period after the loan is made: payroll costs; mortgage interest (but not prepayments or principal payments) and rent payments on mortgages and leases in existence before February 15, 2020; certain utilities, including electricity, gas, water, transportation, and phone and Internet access for service that began before February 15, 2020. (see attachment entitled: Summary of CARES Act Provisions for more information). These loans must be applied for through your lending institution or bank.

How then do congregational leaders face this daunting task of sifting through these options while providing pertinent information through which discernment can be made?

The presbytery is encouraging congregations to consider doing a cash flow analysis as a first step before making decisions about how to move forward on requests for payment assistance or funding of the mission and ministry of the congregation. If, after doing this cash flow analysis, you find that your church should be able to withstand then next several months, then please consider whether you should apply for a loan. Since there is a finite amount of money available, we hope those that need it most will have access to it.

To assist you with forecasting cash-flow, attached please find a spreadsheet that can be used to estimate monthly and year-end cash balances available to support your ongoing ministries for planning purposes. During these unprecedented times, there hasn't been an overabundance of hard data available to serve as a basis for discernment. Although the attached spreadsheet includes worksheets for 12-months and an annual statement for 2020, I've used this spreadsheet to develop multiple forecasts - focusing on receipt estimates to include a range from 1) a possible severe decrease, 2) a less severe percentage decrease, and 3) to no impact on giving for the months of April, May and June 2020, with gifts and receipts for the months following June slowly beginning to normalize. Likewise, scenarios regarding expenditures can be made to provide a full range of options.

The objective is to provide estimated information and data for your leadership and possibly to share with your partners at the presbytery as we help you evaluate available resources and other potential sources of assistance.

Please note that the fields highlighted in "yellow" on the spreadsheet require your input of the data for your church family. Other fields should calculate automatically.

If you feel you should apply for a PPP loan, please contact your bank or lending institution to begin the process. We've included several attachments including a Q&A for faith-based orgs and an application form. The information about this loan program is changing daily and your bank or lending institution should provide the most up to date info.

- April 14, 2020, I recommended the following to Beulah Presbyterian Church.(Sale of their manse)
  - 1. I informed them that the first step was to gain approval from their session as to how they wanted to proceed.
  - 2. I also suggested that they might want to review the churches by laws because as in most of these cases issues of capital expenses or income might be an issue and it might require congressional approval. C-
  - 3. I informed them that once the congregation made a decision a formal request would have to be sent to GRP describing in detail as to their intentions. That upon receiving the request unless GRP had an issue with the action it would give the church the approval to proceed, but before finalizing any transaction it would have to gain final approval from GRP. I assured them that now that the GRP Admin team has been given final approval on real estate issues the response from a GRP would be very timely. I also told them that I had a concern because of the fact that the land and house were donated was there a legal deed produced, naming the church as sole owners. I strongly suggest that the church proceed to procure a league deed and to make sure that GRP was named in the deed as an interest party in any future transactions.

# TREASURER'S REPORT

### Treasurer's Report

While we live in uncertain times, churches continue their mission through payments of per capita, missions, special offerings, and reaching out to their congregants in many different ways. I am very grateful for the churches of the Presbytery of Great Rivers who have been faithful in their financial support of our Presbytery, Synod and Office of General Assembly. I am also thankful for Sabrina, our bookkeeper, who, while tending to her children and their school work, has been able to carve out enough time to bring our finances up to date and for Patti, who ensures your checks are properly accounted for and deposited.

In reviewing the results from the end of April, you will notice a large amount of money in our checking and CD account. Our CDs total \$150,000 and the checking account houses the remaining roughly \$150,000. This is because you have been faithfully paying your per capita and mission money. During April, we closed the office except for the few checks that I wrote to support the Zoom initiative. The money we normally send on to Synod and GA had stockpiled in our checking account. May will see about \$50,000 passed on to those entities as well as our rent to FFC, which was graciously postponed. Our investments have taken a hit just like many others' accounts, but we are monitoring our cash flow to ensure enough money is available to carry out the work of the Presbytery. God bless you all; stay safe.

# LEAD PRESBYTER REPORT

Report of your Lead Presbyter for Transformation, 5/31/20

Three of the last four months since my last report have been co-shepherding our community of churches through ministry during the worst global pandemic since 1918, and the first in post-Christendom ministry. Because most of my energy went towards responding to the pandemic, that will be the primary focus of this report (as a shout-out to the excellent, in-person ministry safely done from 2/8 - 3/14, those images are included here as well).

Since the beginning of the pandemic, I understood my role as one of resourcing, connecting, and encouraging our church leadership as challenges changed week to week, being particularly attentive to the congregations experiencing emergencies on top of the crisis of the pandemic. To that end, safely from home, I employed electronic means of weekly newsletter, phone, and Zoom to connect with church leaders up and down the presbytery, including the offering of six weekly check-ins by Zoom from mid-March to late April. For different instances of facilitating care and mission, I have directly interfaced with the leadership of the Synod of Lincoln Trails, the Board of Pensions, Office of General Assembly, Office of Preparation for Ministry, and Presbyterian Disaster Assistance. On top of the use of discretional relief funds, I was also able to advocate to the PDA for an emergency grant for United Korean Presbyterian Church in Springfield, a church still reeling from a vehicle accident through their sanctuary in December, so they can feed their vulnerable Korean speaking population through the pandemic (the Admin Team was gracious enough to cover the rest of what the PDA grant did not supply). I have also assisted no fewer than six congregations through pastoral searches, two of which have or are in the process of finalizing calls in spite of the pandemic.

Here is a timeline of how events unfolded in our presbytery:

**2/28:** earliest resources shared by presbytery newsletter about preparing for outbreak of disease.

**3/11:** a global pandemic declared by World Health Organization.

**3/12:** after consulting with local health departments, a video-blog was shared on Facebook about best health practices for worship.

**3/13:** in consultation between the Stated Clerk and Lead Presbyter, presbytery offices were closed to visitors and all presbytery committee gatherings were required to gather online only; also, first communication on the "state of the presbytery" and recommendations with resources sent out by email

**3/14:** first case of the coronavirus confirmed in the bounds of our presbytery, first in Tazewell County east of Peoria, then later in Sangamon County; a Sixty Second Sermon style video distributed demonstrating CDC recommendations; approximately half of the congregations of Great Rivers Presbytery suspend worship for Sunday the 15th. Presbytery staff commits to working from home.

**3/15:** began to collate a running list of alternate worship sites for online worship from across our presbytery, shared to Facebook and newsletter.

**3/19:** Visioning Team issues statement encouraging innovative ministry.

**3/20:** governor declares first shelter-in-place order; to our knowledge, all of our congregations complied by suspending in-person gatherings

**4/8:** in coordination with Admin Team and Treasurer, communication distributed offering guidance on the C.A.R.E.S. Act as it pertains to federal relief for churches. At least three churches successfully secure federal aid.

4/9: an Easter address by Lead Presbyter sent out by newsletter.

**4/20:** a second "state of the presbytery" communication sent out from the Stated Clerk and Lead Presbytery updating the presbytery to our response to the pandemic, with new resources preparing for May alternate ministry.

**5/5:** another Sixty Second Sermon video distributed by Lead Presbyter demonstrating considerations of resuming worship during a pandemic.

**5/7:** a list of "Top Ten Reasons Why Your Pastor Needs a Break" and distributed by Lead Presbyter in newsletter and again as a blog post.

**5/19:** a statement on COVID-19 was issued by the Leadership Team with important considerations on pandemic ministry, celebrating that because of precautions so far, there have been no reported cases of the virus within our congregations, urging following CDC, governor, and local health department guidelines, and also to consider needs of pastors and staff.

**5/29:** governor declares entering into Phase Three: gathering size still limited to 10—a handful of churches begin making plans to resume with in-person worship with safety measures, at least two drive-in worship services, many more remain virtual through June; presbytery office staff is permitted to return to office, with masks if two or more in same room and maintaining six feet of distance at all times, with all in-person committee work remaining suspended and facilitated electronically with the office's help.

Fortunately, the presbytery operation itself has continued relatively unhindered; approximately a dozen committee meetings have had their necessary business by Zoom so our ministry could continue. Because we have been practicing online gatherings for two years now, a large number of presbyters have obtained experience with Zoom capability. Being accustomed to myself working both in and out of the office on weekly basis further enabled us to remain responsive to the needs of the presbytery while locked down. I should share that because my Lyme Disease symptoms can restrict my breathing, I am among our vulnerable population and thus will continue working safely from home as much as I can through the summer. Also, I have been blessedly held accountable by the good people of this presbytery to be sure that I am practicing my own advice for self-care and rest, so I will be taking vacation time for two weeks after the conclusion of this Tuesday's virtual assembly. We have a strong, wise, resilient, and resourceful presbytery! It has indeed been an amazing blessing to be called to this time and place to do responsible ministry with you.

### **AVAILABLE SHARED MISSION GRANTS**

- Approved a new weekly, six month "companion" program for incoming pastors, which would pair them with a selected companion from within the presbytery to be available for on-boarding and settling into our presbytery context. (found in supplemental papers)
- Explored available resources for assisting churches uniquely affected by the pandemic crisis, particularly through group therapy options for uniquely affected churches.
- Approved a number of contracts to ensure fair and equitable pastoral arrangements between pastors and congregations.
- Approved updated language for ministry partner transitional church levels (found in supplemental papers)

# **COM CLERGY COMPANION**

### **Background**

When a Pastor is called to serve a congregation in a new Presbytery, there is a time of great transition. Not only does the pastor have to move to and acclimate to a new community and church culture, they also are part of a new Presbytery. In order to help facilitate this time of transition for the newly called Pastor, the Presbytery will provide the Pastor with a companion who will walk with the Pastor in their new role. Ideally, this companion would be familiar, not only with how the Presbytery functions, but would also be familiar with the community and faith community to which the Pastor has been called. The role of the companion is different from the role of COM Ministry Partner. The role of the COM Ministry Partner is to provide a connection between the pastor and the faith community with the COM. The role of the companion is to serve as a connection with Presbytery while also facilitating a smooth transition into ministry in their new call.

### Selection of Companions:

Companions will be identified by a group made up of COM members and Presbytery leadership based on proven effectiveness in the role and their willingness to make the relationship one of the priorities of their ministry during the assigned time. Companions will be recruited to represent the wide variety of racial ethnic composition, gender identity, faith community size, and staff position description.

### Ideal Characteristics of a Companion

- Calm presence
- Able to see and celebrate the gifts and strengths of the new leader
- Proactive and reliable
- Understands the breadth of the church and the work of the presbytery
- Well differentiated
- Enjoys their ministry
- Demonstrates collegiality
- Well versed in Presbytery of Great Rivers structure and resources
- Knows their assembly-wide colleagues

# **Companion Duties**

The Companion agrees to initiate monthly contact with their Pastor colleague for the first 6 months of their new call. They will pray regularly for their ministry colleague daily. They will be available by phone or email or in-person meetings before the next stated Presbytery meeting to ensure that their colleague is able to register and has received Presbytery documents.

### Topics for Discussion Might Include:

- Building relationships with the Presbytery
- Discussing the structure and working dynamics of PGR
- Providing an introduction with their Companion at their first attended meeting of PGR
- Discussing pertinent dynamics and history of the congregation, with particular emphasis on the congregation's relationship with Presbytery.

### Evaluation and Feedback

The Companionship will end after ??? An evaluation form measuring the effectiveness and help of the relationship will be sent to the COM leadership team responsible for assigning companions.

# **COM Levels of Pastoral Engagement**

COM Categories for Frequency of Ministry Partner Contact (Fluidity in movement either by actions from the congregation or response of the ministry partner)

- Level 1 Immediate Transition Monthly Contact a) When a pastor leaves b) Actively seeking a pastor (may have an interim) c) Significant conflict d) Actively moving toward shared ministry or dissolution
- Level 2 Open-Ended Transition Quarterly Contact a) Without a pastor but not actively seeking
  - b) Less than full time pastor who is not Presbyterian
- Level 3 Stable Transition Semi-annual Contact a) Called and installed pastor b) Long term stable contract pastor

### Expanded Teleconferencing Grants

On April 30, 2020, the Leadership Team expanded the Zoom grant to include the following:

From April 1, 2020: the Leadership Team approved <u>grants for churches for a one-year subscription to</u> <u>ZOOM for teleconferencing</u>. You may be reimbursed monthly for as long you need it up to a year or be reimbursed for a single year.

- c. Black out any credit card number that might have been used and scan the invoice.
